TERMS AND CONDITIONS

1. DRESS CODE

Smart, Evening attire Appropriate footwear mst be worn No decorations will be able to be brought into the event by patrons.

2. AGE RESTRICTIONS AND IDENTIFICATION

- **a.** This is over 18yrs event. However children can be accommodated at Salt Meats Cheese provided that they are accompanied by an adult 25 years and over.
- **b.** All guests must present valid photo proof of age ID upon entry. This is a driver's licence, passport, or other valid photo identification card. Failure to provide valid photo identification will result in the ticket holder being denied entry to the Event.
- **c.** Each guest must present a valid ticket and name at the time of admission to the Event to gain access.
- **d.** A reservation booked or purchased from a source other than Salt Meats Cheese, Bar Ombré, or Eventbrite will not be recognised and will not gain entry to the Event.

3. RESALE OF TICKETS/REISSUE

- **a.** Unauthorised resale or duplication of a reservation will prevent the holder from being admitted to the Event.
- **b.** It is a condition of the sale of tickets that you will not resell your ticket on an unauthorised website such as eBay or Gumtree.
- **c.** Tickets are not to be used for advertising, promotion or other commercial purposes without the written permission from Salt Meats Cheese or Bar Ombré.

4. VENUE ACCESS

- **a.** All ticket holders will be subject to a search of the person and/or a bag search for security purposes. Each ticket holder gives consent to such a search. If a ticket holder does not permit that search, he/she will not be permitted to enter the Event.
- **b.** A delay may be experienced at the entry point to the Event while reservations are checked, and identification is checked.
- **c.** If you arrive before 7.00 pm for the Bar Ombré event, you will be asked to wait in an assembly area until ticket scanning.
- **d.** Information regarding road closures will be available, when released, at <u>www.rms.nsw.gov.au</u>.

5. THE EVENT

- **a.** Salt Meats Cheese and Bar Ombré Management or authorised staff, acting reasonably, reserve the absolute right to deny admission to any person to the Event.
- **b.** Although Salt Meats Cheese and Bar Ombré will endeavour to adhere to the advertised program and package, Salt Meats Cheese and Bar Ombré reserves the right to vary elements of the Event program and package at its sole discretion.
- c. There is to be no glass, alcohol, or illegal substances brought to the Salt Meats Cheese and Bar Ombré Event. Anyone breaching these conditions will be removed from the event.
- **d.** Salt Meats Cheese and Bar Ombré will not take responsibility for any loss or damage to your property (including personal property such as cameras, bags or money) brought to or

purchased at the Event by you or your invitees, or for injury to the person or death of you or your invitees at the Event or in the common areas.

- e. Salt Meats Cheese and Bar Ombré adheres to the responsible service of alcohol standards. Patrons who are intoxicated, under the influence of illicit drugs, inappropriately attired, or behaving in a drunken, disorderly, or inappropriate manner will be refused entry or removed from the Event.
- **f.** Doors open at the Event at 7.00 pm, and the Event closes at 1.30am. All patrons must vacate the site by 2am. Any patron not doing so will be escorted from the Event and the site.
- **g.** In the event of an actual or suspected emergency of any type or threat to the security of the Event, Salt Meats Cheese and Bar Ombré may give a directive to evacuate the Venue and the site and/or prevent people from entering the Venue.
- h. All dietary requirements must be communicated to Salt Meats Cheese and Bar Ombré 72 hours prior to the event to ensure these needs can be met. Any dietary requirements not communicated may result in Salt Meats Cheese and Bar Ombré being unable to provide a suitable alternative.
- i. The Bar Ombré beverage package is available for a three-hour duration and will commence at 7pm sharp. Please be aware last drinks will be offered 15mins prior to the allocated completion time of 10pm. Salt Meats Cheese and Bar Ombre practice the responsible service of alcohol. Multiple beverage orders per person will not be permitted in line with our RSA requirements. By law, management reserves the right to cease serving alcohol should a patron show signs of intoxication.
- **j.** Salt Meats Cheese and Bar Ombré reserve the right to restrict the volume of alcohol being consumed for any guest present at the event.
- **k.** All seating requests will be taken into consideration but are not guaranteed. Please advise when confirming your reservation of any highchair requirements & prams you will be bringing.
- I. Any outstanding amounts that have not been settled & paid at the completion of your booking will be charged by us to the credit card provided by you and held on file.

6. CANCELLATIONS AND REFUNDS

- **a.** Salt Meats Cheese and Bar Ombré reserve the right to cancel the Event for any reason either before or during the Event.
- **b.** In the unlikely event of cancellation of the Event due to Covid-19 and government direction we will provide a refund of some or all of the ticket price to the original purchaser of the ticket to the extent that we are required to do so by law. You acknowledge that in order to receive a refund in these circumstances you must make application to Salt Meats Cheese and Bar Ombré for a refund within a period of 14 days of cancellation and you must produce a copy of your photo ID and the credit card used to purchase your ticket in order to obtain a refund.
- **c.** In the event of cancellation due to your own circumstances, regarding Covid-19 isolation and contact tracing a refund will be provided upon receiving proof from Service NSW of this misadventure.
- **d.** For other reason for cancellation, a credit voucher will be provided, as long as 48 hours notive is provided.

- e. If you wish to cancel your ticket, we kindly ask that you contact <u>events@smcg.com.au</u> at least 48 hours prior to the event. Failure to provide 48 hours notice will result in the ticket being forfeited.
- f. Tickets to Salt Meats Cheese and Bar Ombré event are 100% non-refundable. A credit note will be provided for this cancellation.
- g. No refund of the ticket price (in full or in part) will be offered in any other circumstances including but not limited to inclement weather, cancellation of fireworks for whatever reason, your failure to adhere to the Conditions and/or the Supplementary Conditions, any actual or suspected emergency or threat to security, a change in your personal circumstances, your inability for any reason to attend the Event, eviction of you or your invitees from the Event, or if you leave the Event.

7. COVID REGULATIONS

- **a.** The event will be run adhering to current NSW Health and Government public orders. All Salt Meats Cheese staff are fully vaccinated and mask wearing will be enforced where necessary as well as all other Covid-Safe measures.
- **b.** All guests in attendance for the event agree to follow the latest guidance and restrictions given by the government of Australia in relation to any pandemic, outbreak or health concerns. Any guest failing to follow guidance or comply with restrictions, will be removed from the event.
